\$1000	>10 kW	3.5 ★ (AEER and COP ≥4 ★)

Only demand response capable split systems are eligible.

How do households and small businesses get this offer?

They can only claim it through an installer approved by Air Conditioning Incentives (ACI). ACI partners with the NSW Government to deliver this offer.

Why should I become an approved installer?
